Dear Friends,

This annual report is different than any reports of the past because this has been a year like no other. The COVID-19 pandemic, considered the most crucial global health crisis of the century and the greatest challenge that humankind has faced since World War II, has impacted every aspect of society. Our Riverside Foundation family has felt the sting from this disease in many ways. Although we were not able

to celebrate various events and activities in the traditional way, we choose to do that here. In the pages of this report, we will celebrate life, accomplishments, changes, and overcoming challenges.

This year, while the world has dealt with the health, human, social, and economic crises caused by the COVID-19 pandemic, Riverside has also experienced a unique set of challenges—some caused by the pandemic and others not. At the start of 2020, a new Executive Director from outside the organization brought changes, challenges, and concern about the unknown. Within just a few weeks, we needed to find a new location for our day program, perform construction modifications to the new building, and move the program from its former 20,000 square foot location into the new 10,000 square foot space. That would seem to be enough stress for one year. However, at the time, we did not know what was still ahead. The COVID-19 pandemic sent Riverside into a total lock down in March 2020 in order to save lives. Only three months into the calendar year, we had already experienced an unprecedented amount of challenges for an agency to overcome. Yet, as the pandemic bore down, in-person fundraising had to be cancelled, and we faced one more large hurdle—developing new ways to fundraise.

Today, in the world around us, vaccines are now in distribution, and the hope of returning to a more normal way of life is beginning to surface. At Riverside, we emerge from all these challenges better because of the dedication of our staff, the resilience of our individuals, and the overwhelming support of our donors, guardians, and families.

These actions show that no one stands or walks alone. I hope you enjoy our 2020 Annual Report.
